2022 was a fantastic year for the Credit Union, beginning with our Belle River Community Credit Union partnership. This merger provided our members with another location to transact their banking and for the 1,500 Belle River Community Credit Union members to benefit from the great products and services you have enjoyed over the last 65 years. Over 22,000 members accessed our award-winning services via remote technology or at our seven branches.

A 97% Satisfaction Rating from our members was another highlight. Thank you for your survey responses; it was the highest engagement we have experienced. Your satisfaction scores demonstrate that we provide the superior service levels, expertise, and security we promise to members. The most frequent comments were about how professional, friendly, and reliable we are and how easy it is to bank with the Credit Union. The executive team and board of directors reviewed each response and an action plan developed by leadership to enhance your member experience.

On National Credit Union Day, FreeStar Financial celebrated your membership and contributions with donuts and cider. The week was filled with daily giveaways and featured a 1-Year Certificate of Deposit sale. During Make a Difference Day, our hardworking and committed team members volunteered on a Saturday to assist local organizations or rake leaves and clean yards for residents. We had 90% of our team members participate and donate over 200 hours of community service.

FreeStar Financial also participated in Michigan's first annual Credit Union Kind Day. The Michigan Credit Union League created this statewide campaign for credit unions to show how much they care. Our collective efforts helped to spread kindness, impact communities, and create awareness about credit unions. Michigan's 2022 CU Kind Day included 74 participating credit unions and 3,500 volunteers. Together, we affected more than 23,500 people and raised over \$148,500 in goods and donations. FreeStar Financial participated by hosting free shred days at our Chesterfield, Shelby Township, and Sterling Heights branches.

Throughout 2022, FreeStar Financial was more active in the community than in any past years. The Credit Union proudly supported our 2022 charity, Vets Returning Home. Your involvement and donations helped to raise funds and awareness to support their mission to end veteran homelessness. Since we selected this charity in June, FreeStar Financial has presented Vets Returning Home with over \$3,600. Proceeds were raised during shred days, the dunk tank and raffles at our 3rd Annual Halloween Stroll, sales of plush animals, and team member Jean Days. Our goal is to raise a minimum of \$10,000 through 2023 for this charity.

FreeStar Financial also partners with the Metro East Chapter of Credit Unions on fundraising. People helping people is at the heart of what we do as credit unions, and we combine resources for a more significant impact. This year's efforts allowed the Chapter to present \$7,700 checks to Vets Returning Home and the Play-Place Autism & Special Needs Center. Our group of credit unions also donated gifts for Friends of Foster Kids to share at Christmas. The Chapter's joint reach in 2022 has extended as far as raising funds to support Ukraine.

Thank you for such an outstanding and rewarding year. There were several ways to get involved, and we enjoyed each opportunity to serve our members and benefit the community.
